PRESIDENT'S COMMENTS

Ann mentioned that Patti Miller is in the new position of **New Villagers Liaison**, with the understanding that she would replace herself once she's no longer in New Villagers. This position is intended to maximize our exposure to newcomers in the Village.

Ann asked members to **consider positions as committee chairs and/or Board members** for next year. Many of our current chairs and Board members will be leaving positions after this season.

Ann reminded us that we have accepted an **invitation from Rarity Bay** to start a yearly event, alternating courses each year. Each club will play for a trophy that will reside with the wining team until a new winner is decided the following year. It will not be played on league day.

COMMENTS FROM JEFF HARRINGTON, PRO

- Jeff admitted that he, and the other pros, wear many hats. He claimed our league "is the best part of his week". (Thought we should have this in writing.)
- If you missed signing up on **Chelsea** for play day and want to play, get in touch with Jeff and he will be sure that you get to play.

- **Points** were explained by Jeff and Sarah Havens. Points are earned weekly for 1st, 2nd, and 3rd places along with winners of closet to the pin. Points are turned into money to be spent in one of our pro shops.
- If there is **inclement weather** on play day, we will receive an email that is sent out at 7:30 am on league day. Individuals may decide whether they want to play or not even if league play is cancelled.
- Each person is responsible for **posting** her score in the GHIN system. It is suggested that we post hole-by-hole allowing the system to automatically adjust for handicaps. On play day each team will be given two cards. Both cards should be kept, compared at the end of the game, and one card turned into Jeff. There will be periodic checking to make sure none of us has forgotten to post our score.

After all business was concluded, Ann asked for a motion to adjourn the meeting. Carolyn Sherwood moved that we adjourn. Janet Kincaid seconded it. The motion carried. We adjourned at 1:10 pm.
